Abstract (Times New Roman, bold, 15 pt, no numbering)

This document provides instructions for preparing the full paper to be submitted to EurOMA 2013 by **April 08 2013**. Papers received after that date will not be included in the Conference Programme, Book of Abstracts or USB-collection of papers. The overall length of the paper, including all illustrations, tables, and references, is limited to **10 pages**. *Papers exceeding this limit will be returned to their corresponding author.* The abstract should not exceed 100 words. An identical abstract should be typed separately in the abstract field of the paper submission web page. (Text: Times New Roman, 12 pt, justified). This identical abstract will appear in the Book of Abstracts.

Keywords: Keyword 1, Keyword 2, Keyword 3 (up to three (3) keywords)

General instructions (Section heading: Times New Roman, bold, 12 pt, no numbering)

The paper should be prepared using ISO A4 paper size (210 x 297 mm) using the **Times**

New Roman (12 pt, justified) font according to the format described in this template. *Authors are urged strongly to follow these instructions to ensure the production of a uniformly high-quality Book of Abstracts.* The first paragraph of each section and subsection should not be indented.

Following paragraphs indented 0.5 cm.

Margins should be: top 3 cm, bottom 2 cm, left and right 3 cm each. The overall length of the paper, including all illustrations, tables, and references, is limited to **10 pages**. *Papers exceeding this limit will be returned to their corresponding author.*

<1 line spacing before subheading and section heading, no space after heading and subheading>

Other details (subheading: Times New Roman, italics, 12 pt, no numbering)

Pages should be numbered in the page footer, including the first page, as here. Papers should be organized in the following sequence:

- Title of the paper, name(s) of the author(s), affiliation(s)
- Abstract
- Keywords
- Main subject text
- Acknowledgments (when applicable)
- References

Bulleted or numbered lists should have hanging indent by 0.5 cm. Avoid using more than two levels in the lists.

Following paragraphs indented 0.5 cm.

Footnotes should be avoided. The corresponding text should be incorporated in the main text.

Equations should be typed flush with the left-hand margin and numbered consecutively with numbers in brackets on the right. Leave single spacing above and below equations, like shown in equation (1).

$$\sum_{i=1}^N x_i = \delta$$

Figures and tables must be included in the main text and must be individually numbered and captioned. Illustrations should be sharp and clear. Place figures and tables centered. Captions should be placed **below figures** and **above tables**. They are typed in Times New Roman 11, in italics, and centered. Leave one line before and after tables and figures (see examples below).

Language

All papers must be in good English. Please proof read carefully your own paper.

Mistakes cannot be changed later.

Once the final version of the full paper PDF has been submitted, **the document cannot be corrected or changed later.**

Conclusion

The above has shown the main instructions for writing the text. All is missing now are instructions regarding references.

References to other publications should be in Harvard style, Times New Roman, 10 pt, left aligned, hanging indent 0.5 cm. They should contain full bibliographical details. Journal titles should not be abbreviated. References should be presented as follows. Within the text: Author's last name followed by a comma and the year of publication, all in round brackets; e.g., (Fox, 1994). When the number of authors is three or more, references in the text should be (Fox et al., 1995). At the end of the paper, list all references in alphabetical order. In the reference list all authors should be included. *The complete list of references should be included within the 10 page limit allowed for the full paper.*

References

A full reference list should be included

For books: Surname, Initials (Year of Publication), *Title*, Publisher, Place of Publication.

Casson, M. (1979), *Alternatives to the Multinational Enterprise*, Macmillan, London. (Times New Roman, 10 pt, left aligned, hanging indent 0.5 cm).

For chapters in edited books: Surname, Initials (Year), "Title", in Editor's Name, Initials (Ed.), *Title*, Publisher, Place, Pages.

Bessley, M. and Wilson, P. (1984), "Public policy and small firms in Britain," in Levicki, C. (Ed.), *Small Business Theory and Policy*, Croom Helm, London, pp. 111-126.

For articles: Surname, Initials (Year), "Title", *Journal Name*, Volume, Number, Pages.

Fox, S. (1994), "Empowerment as a catalyst for change: and example from the food industry", *Supply Chain Management*, Vol. 2, No. 3, pp. 29-33.

Electronic sources should include the URL of the web site at which they may be found along with the date of latest access.
